

Lessons learned:

Among the negative aspects: The children's parliament members suffer from the rugged Aden-Taiz road.

Positive aspects: Holding parliament sessions at the governorate level is a rather useful experience, as it puts children in the situation of children in Taiz. For example, the city of Taiz suffers from the interruption of roads and safe crossings, which exposes the population to dangers, including children.

We will find among the recommendations calling for the opening of roads and crossings in the city of Taiz for civilians.

The children were able to prepare the recommendations of the second session, which include: 1-6 general recommendations.

2-8 recommendations issued by the Human Rights Committee.

3-3 recommendations issued by the Culture and Media Committee.

4-9 recommendations issued by the Education Committee.

5-4 recommendations issued by the Health and Environment Committee.

Each of the children in the governorate they are in will start holding government meetings to deliver recommendations and prepare for an advocacy campaign for the Convention on the Rights of the Child.
