



COVID-19 Regulations

Thank you for joining the KPSRL 2021 Annual Conference: Asymmetric Power in The Hague. Before your arrival we would like to inform you about the regulations regarding COVID-19.

Basic Rules

Please note that you must comply with the following basic rules when in The Netherlands:

- Wash your hands often.
- Maintain a distance of at least 1.5 meters from other people and avoid crowds.
- Stay at home if you have symptoms that may be caused by a COVID-19 infection and take a test.
- Cough and sneeze into your elbow. Use paper tissues and throw these away.
- In most places, you no longer have to wear a face mask. However, it is still mandatory for any person aged 13 and over in places where social distancing (1.5 m) is impossible. Examples include vehicles, public transportation, railway and metro stations, airports, and aircraft.

Entering The Netherlands from abroad

Before you travel, consult this [checklist](#) for current travel bans and the rules regarding testing and quarantine in the Netherlands. Find your country in the lists and check the requirements that apply for you. Note that as of September 22 vaccinated travelers from very high risk areas such as the United States or the United Kingdom no longer have to self-quarantine on arrival in the Netherlands.

Access to KPSRL 2021 Annual Conference: Asymmetric Power

To gain access to the KPSRL Annual Conference you will have to show your [EU Digital COVID Certificate](#) (DCC) to demonstrate your vaccination status upon arrival at the venue.

Please make sure that you have the following ready when arriving onsite:

- Your photo ID
- Digital COVID Certificate proof of vaccination, recovery or 24hr negative test result

EU Digital COVID Certificate

Dutch participants can use their **CoronaCheck** app. Participants from other European countries can use the EU Digital COVID Certificate (DCC) of their own country. Visitors from countries that do not use the EU DCC need to get tested beforehand through Testing for Entry (Testen voor Toegang), www.testenvoortoegang.org. **Even if they are fully vaccinated**. The test result can then be uploaded in the CoronaCheck app. (See further instructions below)

The event staff will be able to scan every EU DCC using the Dutch CoronaCheck Scanner app.

Step 1: Use your EU Digital COVID Certificate, download the CoronaCheck app or print a paper COVID Certificate from CoronaCheck.nl

CoronaCheck works on smartphones running Android (Android 6 or later) and iOS (iOS 12 or later, on iPhone 5s and later). The app can be downloaded free of charge from the Google Play Store and the Apple App Store.

The app currently supports Dutch and English. If you wish to change the language of the app to English:

iOS: Please select your preferred language in the settings of your phone.

- o Go to settings*
- o Go to CoronaCheck*
- o Go to language*

Android: The CoronaCheck app uses the language your phone is set to. To change the language of the app, change the preferred language in the settings of your phone.

Step 2: Upload your proof of vaccination or proof of recovery or negative test result.

*If you cannot prove your vaccination status with a DCC, you will need to make an appointment for a test at one of the locations listed at www.testenvoortoeegang.org. Make sure you get tested within 24 hours before the start of KPSRL Annual Conference (i.e. 10:00am or later on Oct.13th). See guidance below to **Schedule your “Test for Entry”**.*

If the test result is negative, enter the code of the negative test result in the CoronaCheck app.

*You can **print the COVID Certificate** from the website CoronaCheck.nl. Use this option if you:*

- o don't have a smartphone; or*
- o prefer to have your COVID Certificate on paper; or*
- o don't have the app installed on your phone*

Step 3: Have your QR code scanned upon arrival at the venue.

The CoronaCheck app or the website CoronaCheck.nl automatically registers your proof of vaccination, proof of recovery, negative test result in the form of a QR code. You can have this QR code scanned at the KPSRL Annual Conference venue entrance. If the screen is green, you have a valid coronavirus entry pass.

The QR code of the coronavirus entry pass only shows the person who scans it:

- The initials of your given name(s) and*
- Your date of birth*

The CoronaCheck app does not show whether you have been tested or vaccinated or whether you have recently recovered. The person who scans your QR code only sees a green screen.

Schedule your “Test for Entry” (Testen Voor Toegang)

If you are not able to prove your vaccination status using the EU Digital COVID Certificate, or if you come from a country that does not use the EU Digital COVID Certificate, you will need to get tested.

Please make sure that you schedule your test appointments through www.testenvoortoeegang.org well in advance.

- o Test results are only valid for 24 hours. Schedule your test for **10:00am or later on Oct.13th**.*
- o Registration for tests on October 13th will open on September 29th*
- o You will need a mobile number to receive verification codes for registration and receiving test results (non-Dutch phone numbers are also accepted).*

Step 1: Go to www.testenvoortoeegang.org and click on ENG (Top Left) for English

Step 2: Click on 'make an appointment'

Step 3: Choose 'Business event' as your activity

Step 4: Confirm that you do not have symptoms

Step 5: Enter your arrival date (Oct.14) and time at the KPSRL Annual Conference

Step 6: Choose a location and time slot. (For a test location near the venue: zip code '2518 AD')

Step 7: Enter your mobile phone number to confirm your appointment

Test result

In principle you will get your test result within 2 hours. Sometimes it can take a little longer. You will receive an e-mail with a link to retrieve your test result. The link will lead you to a unique code. Use this code to convert your test result to a valid COVID Certificate in the form of a QR code via the CoronaCheck app.

Go to the event

Please make sure that you bring the following to the KPSRL Annual Conference.

- Your photo ID
- Digital COVID Certificate proof of vaccination, recovery or 24hr negative test result

Symptoms – What to do?

Participation in the KPSRL Annual Conference is at your own risk. If you are in The Netherlands and you develop symptoms that may be caused by COVID-19, confine yourself to your accommodation and get tested. Call 0800 – 1202 (daily from 08:00 to 20:00) or 0800 659 063 to schedule a test. If you are very ill, call the emergency number 112. If you are infected, follow the instructions of the health service.

The KPSRL will retain the right to withdraw admittance or further attendance of visitors who suffer from symptoms of a cold, a fever and/or those who do not comply with safety and precautionary measures.
