Subthemes

REINVENT

The first step is a more theoretical exploration of the concept and its history, which also includes 'unlearning' the problematic assumptions, based on the knowledge of those it affects. We need to reinvent this flawed wheel: here you are dared to dream big (or wake us up), allowed to be conceptual in your innovative reimaginations and encouraged to take creative steps forward into the unknown.

REARRANGE

This step is all about relationships and organization. Let's rearrange our ways of collaborating with communities, partners and stakeholders, restructure the SRoL sector's traditional chains and alliances, and shift participation for political settlements – toward more equal structures. This also entails engaging communities, shifting the power in partnerships, and using our leverage at the negotiating table to open spaces for those whom our actions affect the most.

RENEGOTIATE

This is where we get to action, through interventions and practical tools or instruments. Many of us have already put our reimagined ideas into action successfully, so in this more technical step, we learn from each other's approaches. This is also where tools and instruments are shared to e.g. analyse situations and needs, fund innovatively or measure progress to adapt iteratively.
